However, we were making progress and the account to date had gained about \$20,000 and about a \$7,000 increase from the end of December. Though there was discussion about raising interest rates and what effect that could have on the investments we currently have. She recommended no changes. Cindy left the meeting.

Chief Tharp reported that in addition to Andy Reinhardt, who is selected by the CYFD Board of Directors per the bylaws to sit on the VRRP Board, we also need to officially swear in Director Johnson for his seat since he was unopposed. His appointment was voted and approved last board meeting, just didn't swear him in. Both Directors (Reinhardt and Johnson) were sworn in by Clerk Cody Rose.
